NOW, THEREFORE, in consideration of the premises and intending to be legally bound, the Undersigned hereby covenants and agrees to indemnify, keep indemnified and save the Credit Union harmless from and against, and to release and discharge the Credit Union from, any and all claims, demands, actions, proceedings, judgments, losses, damages, counsel fees, payments, expenses and liabilities whatsoever which the Credit Union, at any time, shall or may sustain or incur by reason of (a) the Credit Union's having certified, issued or delivered, as the case may be, a new or duplicate instrument or having reimbursed the Undersigned for the amount of the Instrument or having credited the amount of the Instrument to the account of the Undersigned, or (b) any claims or demands, whether groundless or otherwise, which may be made with respect to the Instrument, or (c) the Credit Union's declining to honor the Instrument, or (d) the payment, honor, transfer of credit or charge to the Undersigned's account which the Credit Union may give, make or permit with respect to the Instrument, whether through inadvertence, accident, oversight, neglect or otherwise.

The Undersigned agrees to deliver the Instrument to the Credit Union for cancellation immediately upon the same coming into the control or possession of the Undersigned.

The liability of the Undersigned under this Agreement shall accrue forthwith upon the presentation for payment of the Instrument or the assertion against the Credit Union by any person of any right, title or interest in the instrument.

This Agreement constitutes the joint and several representations and undertakings of the Undersigned, if more than one, and shall inure to the benefit of the Sun East Federal Credit Union, its successors and assigns, and shall be binding upon the Undersigned and the Undersigned's heirs, next of kin, personal representatives, successors and assigns, as the case may be.
